

**Parental Waiver, Release of Liability,  
Indemnification and Consent Form**

I, the undersigned, as the parent or legal guardian of the child named below, do hereby give my full consent and approval for my child to participate in baseball lessons, clinics, workouts, strength training, agility training and physical conditioning provided by the employees of, and/or the independent contractors associated with Parkes Run Partners, LLC, d/b/a On Deck Training Center (“**On Deck Training Center**”). I also give my permission for my child to participate (if selected) as a member of certain teams sponsored by On Deck Training Center.

I understand that by its very nature, the game of baseball is hazardous and risky, including, but not limited to, the act of pitching the ball, having the ball hit back at the pitcher, fielding the ball, swinging the bat, running, jumping, and sliding into base.

I understand that there are certain risks of serious injury, or even death, inherent in the practice and play of baseball and in the other activities described above. There are also risks to playing on a baseball team including, but not limited to, hazards associated with weather conditions, travel, playing conditions and equipment. **I am willing to assume these risks on behalf of my child.**

I agree that in consideration for the right to allow my child to participate in the activities described above and/or participate as a member of a team sponsored by On Deck Training Center, and in consideration for permission to utilize On Deck Training Center’s facilities and play on the fields arranged for by On Deck Training Center:

1. On behalf of my child and myself, I voluntarily elect to accept and solely assume all risks of injury incurred or suffered by my child (a) while participating in the activities described above; (b) while practicing or playing as a member of an On Deck Training Center team and (c) while on the On Deck Training Center premises and/or any fields arranged for by On Deck for practice or play.
2. In addition to giving my full consent for my child’s participation, I do hereby waive, release, discharge and agree not to sue (a) On Deck Training Center, its owners, employees and or/independent contractors (b) the owner or operator of any field arranged for by On Deck for practice or play, for any claim, damages, costs including attorneys fees, or cause of action which I or my child have or may have in the future as a result of damages, injuries, including death, sustained or incurred by my child from whatever cause including, but not limited to, the negligence, breach of contract or wrongful conduct of the parties hereby released.

I hereby certify that my child is fully capable of participating in the sport of baseball and the activities described above and that my child is healthy and has no physical or mental disabilities or infirmities that would restrict his or her full participation in these activities.

I further agree on behalf of myself and my child named below, that I shall hold harmless and fully indemnify the parties hereby released from any and all claims, cause of action, damages and costs, including attorney fees, which may arise from any claim or cause of action brought by me or by, through or on behalf of my child, even if the damages, injuries or death are caused in whole or in part by any of the persons or entities hereby released.

**I acknowledge that I have read (or have had read to me) each and every one of the provisions in this waiver, release of liability and indemnification agreement, that I understand each of the provisions in this agreement and that I agree to abide by them.**
